# *TDLA Upcoming Events*

**August 10, 2023** - Join us for the August Next Gen webinar which will focus on **Experts: Onboarding, Disclosing and Deposing** and will be presented by **Scott Rhodes** of *White & Rhodes* in Brentwood, TN. The presentation will take place on Thursday August 10 at 1:00pm EST/ Noon CST and last for one hour. This webinar will highlight common issues involving expert witnesses and provide practical tips and advice on how to address those issues. The presentation will focus on the use of experts in Tennessee state court cases and delineate three phases of expert involvement before trial: onboarding (finding and hiring the expert), disclosing the expert to your opponents and deposing both the friendly and adverse expert witness. Onboarding issues that will be discussed include early evaluation of cases to address the need for experts, how to find the right expert for your case and setting appropriate expectations for the client and the expert. Disclosure issues will include the significance and utility of scheduling orders, drafting the expert's report, compliance with Rule 26 and knowing your venue. Finally, potential pitfalls and strategic considerations for expert depositions will round out the discussion. Topics will include prepping your expert, understanding how the deposition can be used at trial, preparing to depose the hostile expert, defensive and offensive objections and the utility of motions in limine. # *TDLA Emerging Leaders Program*

TDLA President Hannah Lowe is excited to launch the Emerging Leaders program on September 13, 2023. **Emerging Leaders is a Leadership Development Program whereby lawyers in our organization can have the opportunity to learn and develop leadership skills and be recognized for their participation in various TDLA activities.** The program will launch at the TDLA Annual Meeting at Fall Creek Falls State Park in Spencer, TN on September 13-15, 2023. Anyone wishing to participate in the Emerging Leaders Program will be able to sign up using the link on the TDLA website. Each participant will receive a Progress Tracker, which will have space for each participant to mark when a task is complete.

The tasks are divided into two groups: Level 1 (more basic tasks), and Level 2 (more advanced tasks). When members complete 6/8 tasks in each level, they will be recognized as a TDLA Emerging Leader either Level 1 or Level 2 and receive recognition as a graduate of the TDLA Emerging Leaders Program at the TDLA Annual Meeting Awards Dinner, in the Newsletter and/or Journal, and on the TDLA website.

There will be no specific deadline for completion of the tasks on the list; however, if a member wishes to be recognized at the Annual Meeting, the Progress Tracker must be submitted (to [office@tdla.net](mailto:office@tdla.net)) by the end of the month before the annual meeting. Members who have already completed one or more task on the lists at the time of the Program Launch may mark the task complete with the completed date on the Progress Sheet.

Any members who have completed 6 of 8 tasks from either Level 1 or Level 2 by the time of the next TDLA Annual Meeting and submit their form by the end of the month before the meeting (TDLA's next annual meeting will be in October 2024) will be recognized as a graduate of the Emerging Leaders Program at the Annual Meeting. They will also receive recognition in the TDLA Newsletter and/or Journal, and on the TDLA website. We plan to dedicate at least one hour of the TDLA Young Lawyers Boot Camp at the Annual Meeting to leadership training as part of the Emerging Leaders Program.

TDLA is excited about identifying and working with our emerging leaders to help them to develop the leadership skills they need to thrive not just in our organization but in the legal profession generally.
