# 1:30-3:30pm Deposition Bootcamp: Expert Witnesses and Best Practices for Young Attorneys

(2 hours)

Expert witnesses are crucial to cases and young lawyers may make mistakes ranging from inappropriate communication to improperly deposing them. The first hour of this two-part event features a panel discussion and Q&A with two experts providing practical tips and advice for young lawyers regarding communication, retention, and other best practices when consulting or hiring expert witnesses. These experts will also provide instruction regarding preparing for expert depositions, deposing experts, and the best methods to undermine the credibility of an opposing party's expert.

The second hour of this event features practical instruction to attendees on how to depose a liability expert by presenting mock depositions of experts. The depositions of these actual expert witnesses will be conducted by experienced trial lawyers demonstrating techniques on issues such as qualifying an expert, cross examining an expert, handling an expert who declines to commit to a position, and many other issues that arise during expert depositions. This practical portion of the presentation assumes a basic understanding of depositions in general and the TDLA will provide a fact pattern and "how-to" deposition materials to each attendee in advance of the presentation.

### **Presenters:**

### Lindsay Long, Ph.D. – Exponent Engineering & Scientific Consulting

Dr. Lindsay Long received her Ph.D. in Human Factors from Clemson University in 2013.Her research focuses on how humans perceive, move, and interact within their environments, and how the capabilities and limitations of human perception, cognition, and physiology impact their interactions, particularly with respect to safety and safety-related behaviors.

Dr. Long's expertise in understanding how humans perceive and use perceptual information applies to the detection of warnings and hazards, the use of training and safety information, the ability to perceive and navigate walking surfaces, the use of information while driving and operating machinery, and the perception of obstacles and pedestrians under darkness and limited

visibility conditions. She has analyzed human factors issues in product liability, medical malpractice, industrial accidents, slips/trips and falls, and transportation cases, among others. She is also a certified XL Tribometrist, allowing her to scientifically evaluate floor surface conditions relating to human slips, trips, and falls.

### David Cades, Ph.D. - Exponent Engineering & Scientific Consulting

Dr. David Cades received his Ph.D. in Human Factors and Applied Cognition from George Mason University in 2011. He specializes in human factors investigations of aviation and vehicle operator behavior, including perception response time, visual perception, nighttime visibility, advanced driver assistance systems (ADAS), and distractions.

Dr. Cades has expertise in the testing and analysis of how interruptions and distractions affect performance. He has investigated the negative effects of distractions in environments, including, but not limited to, driving, aviation, healthcare, offices, and classrooms. He has applied this knowledge to see how distractions can cause errors that lead to accidents. Dr. Cades has also investigated vehicle operator behavior of automobiles, commercial trucks, bicycles, motorcycles, and aircraft. He has evaluated the adequacy of warnings on products and in their manuals and he has applied his experience to projects involving safety- and health- related user behaviors of industrial equipment, kitchen appliances, video game entertainment systems, home theater products, and personal protective equipment.
