Let's look at the reason for submitting written discovery and what we want to accomplish by doing so. Objectives: (1) determine whether and why written discovery is needed and/or helpful in a file, (2) determine what information is being sought, and the most efficient way to obtain it, (3) determine how to carefully respond to written discovery so as to act ethically but not give away everything we know about the case.
